branches such as the CIA or FBI nor have I accepted any money payment from them for any kind of services rendered. I was and am a completely free and independent (oooooh, those government people all hate that about me . . .) United States and International Lawyer out in the world on my own, slaying Giants.

Therefore, none of the information you see here is what is generally termed Classified.

It is all, rather, my personal and perhaps it might be deemed my proprietary information, some from my experiences in my work between America and other countries such as Israel and China.

Some things come to me through my personal intelligence networks and systems. 7 EXAMPLES OF KILLING LIONS AND BEARS IN THE INTERNATIONAL LEGAL SYSTEM

1. I stopped a team of five Islamist terrorists from reaching America, their planned entry at Los Angeles International Airport (LAX) almost exactly one year prior to September 11, 2001. Their travel I understand originated in the Islamic states in Asia – perhaps Iran and then trekking through the ‘Stans. They were transiting through China to catch a flight to Los Angeles where they were I believe the advanced weaponizing and ground connecting crew for the September 11, 2001 bombers. Chinese snoop on) with a direct specific request to the effect that my information should be passed from our intelligence people to their Chinese counterparts made possible [they were as I understand in fact captured by the Chinese Army and dealt with by the Chinese inside China] were going to emplace in the planes special weapons, perhaps nuclear bombs so that America would not just lose a few buildings in Washington, D.C. and New York City but actually the whole cities of Washington, D.C. and New York City. Yes, you turknagles working in all those pretty white government buildings or making big stock trade money working in the NYSE, instead of having been nuclear-bomb-incinerated at some millions of degrees Fahrenheit, you can thank me now. If you take the actions necessary to get me on the ballot and elected President I may be able to save you again; if you don't I won't. I won't be able to. You may be nuclear-bomb-incinerated at some millions of degrees Fahrenheit because I won't be in the right position to be able to save you.

2. In another situation I cooperated with the FBI to prevent the bringing in to America of another nuclear bomb. This operation or one like it is sometimes shown on TV news programs showing fancy global charts and named something like bojangles.
3. In another situation I took action involving both the FBI and the U.S. Coast Guard to prevent damage to worldwide U. S. Military personnel and systems, including for instance all planes in the air and ships at sea and their crews. This was said to reach all U. S. Military assets and personnel everywhere around the world.
4. In another situation I took action to prevent massive (one figure placed the U.S. Dollar amount at \$1Billion in a three year period) international financial crime directed into America coming out of China by corrupt Chinese persons, perhaps just organized crime type criminal operators but more likely also involving perhaps low- or mid-level corrupt officials, local Party or government bosses from remote locations in China. As this was financial

crime against China in the sense money would be drained out of Chinese working peoples communities by corrupt local factory controllers and so on, as well as financial crimes against America in that it was clandestine entry into the U. S. economy [this in and of itself suggests there would be incidental corruption of U. S . financial law enforcement services such as Customs because incidental bribery would likely be necessary to effect the scheme] of huge amounts of unknown funds that could create disruptions such as inflation to the U. S . or even merely local area economies such as municipalities – one can imagine the mischief corruptions in such places as New Orleans in the wake of the Hurricane Katrina fallapart of civil law and order – and states.

5. In another case I took action to undo a significant Intellectual Property type series of crimes between China and America. This case involved the fleecing by a fellow Chinese of a fine middle class business family in one of China's most important great cities. When I was apprised of the situation I was led to the

door of a room where the family's now senior citizen age Mother was staying. When she saw me she took my hand, led me to sit next to her and looked at me so long without saying anything and finally just with tears streaming down her face I realized I was seeing a terrible tragedy working its malice on these decent ordinary family people. They had been ripped off to the tune of tens of thousands of dollars, their life savings and investments and so on most likely. That was the business-bilking Tiger Shark that ate them alive. There was a *worse* fin in the water though (see 6, following).

6. It is what in China is called simply The Central Government. It is the public face and arm of the Power in China: The Chinese Communist Party. That was the Great White Shark in their waters which could take such bites out of these troubled people they would be completely destroyed. I cannot reveal the specifics but in an American analogy it might be compared to someone stealing the imprimatur and symbols such as Seals and Trademarks used by such peculiar independent quasi-agencies of the U.S.

Government such as the Federal Reserve Board (which is actually I think a group of private banks) and commencing formal open corporate business operations using those auspices. In America people with guns we commonly refer to as *The Feds* would come after such criminal fraud perpetrators. China has their own version; you can just call them *Secret Police*, although it is not the Chinese name it's close enough. I can tell you they are as effective as our FBI is dysfunctional. In any event, as this was International Criminal Fraud involving not just individual persons but the Power behind the government as well as the Central Government itself of what is perhaps becoming our most important and complicated big power relationship I took some interesting measures available to me as a completely free, independent U. S. and International Lawyer which, without leaving a conspicuous trail of guts and feathers, completely undid the perpetrator's actions and restored the Intellectual Property issued under the auspices of the Central Government of China – which therefore had no loss of *Face* – to its rightful

owners and users. Thus I undid the worst of the malice perpetrated against the middle class business family I mentioned above. Thus, as in the massive financial crimes I stopped explicated in number 5 above, this was a crime against both America and China and I set it right for China as well as America. It is partly through such things where as the 26th Psalm I think it is says *I have walked upright in my integrity* that I have become I think a Good Old Friend of China, sometimes said in Mandarin as *Hao Peng You* or *Lao Peng You*. It is a constant in my relations with China I value. I look forward to doing more good works of 2-way transparency between China and America that will benefit my beloved home country of America and an ancient one towards which I have also come to be so warmly disposed. During retirement years I may settle down there six months of the year, spending the other six months in America, to savor the life I have come to love in each country and perhaps work on projects benefiting both America and China.

7. During my time as a SAR EL Civilian Volunteer in the Israeli Army I spoke for some time at a military training college with the Founder and Commanding Officer of SAR EL Major General Aaron Davidi, who appears under a pseudonym in Leon Uris's fine book Mitla Pass as the founder and commanding Colonel of Israel's tough, elite Paratroops, concerning the depredations on Israeli civilians of suicide bombers who simply walked over from the West Bank. In Y2K, the year 2,000, and subsequent years, the losses to Israel from this source were said to be the largest the nation suffered on an ongoing basis, averaging about 2,500 per year which is a painful number of civilians for a small country to lose. He said he could not find any international precedent for a way for two people groups who wanted the same land to be more peaceably managed. Playing the little Dutch boy asked to put his finger in the hole of this dyke, I supplied him with the international legal precedent of the Demilitarized Zone between North and South Korea, which is described quite well in its smallness of size and its functional operation in

one of Tom Clancy's fine books. The DMZ is not in all of its points an elaborate affair; Tom Clancy's book describes it as just a single lane dirt road with a fence on each side. General Davidi brightened up immediately, saying something like Yes, we can work up a kind of Fence. It is my understanding the safety Fence the Israelis erected, which I think has about 70 miles of fencing and four miles of wall, has saved thousands of lives of innocent Israeli civilians. Doing the math, at 2,500 per year, it is likely 10,000 - 15,000 lives were saved during the past five or six years. (If you think I am relating this to get some part of the Jewish Vote, well, I am not. I believe, however, 100% of the *entire* Jewish Vote should be sure to get to the polls and vote for me. 100% of those Christians who understand the special place and role of Israel should do the same.) This time the lives I have saved are not Americans, they are Israelis. Some may take exception to that.

Let me just point out it is within time-honored American Presidential tradition, at times imperfectly kept, to save innocent lives. I would

Government corruption, including murder and its cover-up, committed by the FBI, the USMC and the CIA to be set right and the corruption quelled. This is a *tip of the spear* op to start the present terrible U. S. Government corruption Clean-Up rolling. As President I will remain seized of this question and work to clean up the corruptions in our government.

3. An offer of an Open Hand of Peace to Osama bin Laden, if he will make a true Peace in sincerity.

Part of the reason I make this affirmation deliberately public is that this, our historical faith gives us the weapons of spiritual warfare needed to defeat our present enemy which is an adversarial and expansionist (this is an element they have in common with the former Soviet Union, which the U.S. met with the policy known as *Containment* set forth in a document authored by George Kennan, the head of the U. S. State Department's then new Policy Planning Staff, in the July 1947 volume of Foreign Affairs which became known as *The X*

Memorandum) spiritual belief power. They are the ones who keep calling it a *Holy War*, remember? (This is the problem my mentor taught me about when he was teaching me what happened in the U.S. military aircraft production, which his father and brother engineered, during World War II. See, we hardly had any air force, hardly any fighting planes. We did not want to waste resources on War; we wanted to devote our national treasure to achievements available during Peace like commerce and industry, good infrastructure, health systems, education, the arts and sports. We were making movies like *The Wizard of Oz*, and in color. My mentor taught me: *that is what is so devilish, the Enemy always chooses the weapons. We have to fight back to defend ourselves.*) I should admit there is something about me as a religious believer that drives both Jews and Christians nuts. Jews do not accept Jesus Christ as their Messiah. Christians always want to convince or convert them to do so, and the historical record has been full of bloody atrocities against Jews by a misguided Church such as The Spanish Inquisition and others.

It fairly amazed me to see how many hakenkreuz entries there are today on Google.) and ovens and stuff guys; I am with them on these views. Virtually all churches, I estimate, hate me for this; once in a while some prelate will snarl at me "*Are you a Jew?*" Even Linda The Hon's

24. An honorable high-level U. S. Government official, my Uncle Tommy, who rejected whores forced on him in foreign countries and how I lived out his example in China.

This is important, see, because – setting aside just for now that Wall Street Journal article reported on in a television news show not too long ago where President Bush was shown with Representative Duncan Hunter at a small White House dinner table with him just before he became a Presidential Candidate, where the WSJ
